The Kenya Urban Roads Authority (KURA) is a State Corporation established under the Ministry of Transport, Infrastructure, Housing and Urban Development. The authority is established under the Kenya Roads Act, 2007 and responsible for the management, development, rehabilitation and maintenance of National urban trunk roads.

Box 41727 - 00100, NAIROBI**, Tel: 254 - 020 - 8013844 upon payment of a non-refundable fee of **Kshs. 1,000 (Kenya Shillings One Thousand Only)** for each document in form of a **Bankers Cheque** payable to the **Kenya Urban Roads Authority**. Bidders will be required to attach a copy of an official receipt to the bid document when submitting as proof of payment. For those who will download the document, they will be required to provide their details by registering at the **Manager Procurement office** immediately and before submitting the documents.

Qualification for Tendering (Mandatory)

The bidders are expected to include the following in their bids:-

- (a) Certified copy of Certificate of Incorporation;
- (b) Copy of Valid Tax Compliance Certificate (will be verified on the KRA TCC Checker);
- (c) Certified copy of recent CR12 form -(12 months) from Registrar of Companies ;
- (d) Bidders shall serialize all pages for each tender document submitted; failure to which the bidder shall be disqualified.

Note:

- The certification of documents shall be original and executed by a Commissioner for Oaths; failure to which the bidder shall be disqualified

Other Requirements are as specified in the respective tender documents.

The Criteria of Evaluation of Bids

The criteria shall be as described in the tender documents and this tender notice.

Description of Works

The description and scope of works is as described in the tender documents.

Bid Price and Validity

Prices quoted should include all taxes and must be expressed in Kenya Shillings and shall remain valid for a period of 120 days from the date of tender opening.
