Bidders will be required to attach a copy of the official receipt to the bid document when submitting as proof of payment.

2. Copy of Valid Tax Compliance Certificate (will be verified on the KRA TCC Checker)
3. Submit a Certified Copy of PIN/VAT Certificate.
4. Certified copy of CR 12 form (Recent within 12 months)
5. Manufacturer's Authorization Form.
6. Bidders shall serialize all pages for each tender document submitted; failure to which the bidder shall be disqualified.
7. Others as described in the Tender Document.

- Certification of documents shall be original and executed by a Commissioner for Oaths.
