The same information may be accessed in websites at www.kura.go.ke/tenders, https://supplier.treasury.go.ke, Bidders will be required to attach a copy of an official receipt to the bid document when submitting as proof of payment. For those who will download the document, they will be required to provide their details by registering at the Regional procurement office immediately after the site visit and before submitting the documents. No bidder shall be awarded more than one contract.

Qualification for Tendering (Mandatory)

The bidders are expected to include the following in their bids:-

(a) Certified copy of Certificate of incorporation

(b) Certified Copy of VALID Registration Certificate with the National Construction Authority in the classes specified above

(c) A copy of VALID Tax Compliance Certificate (Will be verified on the KRA TCC Checker)

(d) Certified copy of RECENT CR12 form -(12 months) from Registrar of Companies

- (e) Acopy of VALID certificate of registration in a target group issued by the National Treasury or th respective County Treasury in the relevant Category for those tenders reserved for Youth, Wome and Persons with Disability.
- (f) Bidders shall serialize all pages for each tender document submitted; failure to which the bidde shall be disqualified.

NB: Note:

- The certification of documents shall be original and executed by a Commissioner for Oaths. This
 shall be used as part of qualification requirement;
- To enhance equity, bidders shall bid for a maximum of two (2) tenders pursuant to this tende notice. This shall be used as part of qualification requirement;
- Bidders with history of non-performance in KURA e.g. failure to complete the projects within th
 contract period, termination of contract or having been issued with a notice of termination ar
 ineligible to bid.

Other Requirements are as specified in the respective tender documents.

The criteria of evaluation of bids

Description of Works

The description and scope of works is as described in the tender documents.

Mandatory site visits and tender opening shall be held on the date and time as per the schedule below starting at the indicated places. Every Bidders shall be represented by one Person bearing a letter from th company authorizing them to represent in the pre tender site visit. The letter shall be in the official compan letter head giving name and National Identification/ passport no of the representative who shall be require to present their original identification during the Pre- tender site visit. This shall be used as part c qualification requirement.
