TENDER NOTICE

The Kenya Urban Roads Authority (KURA) is a State Corporation in the Ministry of Transport, Infrastructure, Housing, Urban Development and Public Works; established under Kenya Roads Act, 2007 with the core mandate of Management, Development, Rehabilitation and Maintenance of National Urban Road Network. As a leading Government Agency with the above mandate, KURA wishes to invite bids from eligible construction companies for road works as described below to be funded through Fuel Levy Fund (RMLF).

Interested bidders MUST be registered with the National Construction Authority (NCA) road works categories as indicated below:-

Box 5585 - 30100, ELDORET, Tel: 254 - 020 - 2625453 upon payment of a non-refundable fee of Kshs. 1,000 (Kenya Shillings One Thousand Only) for each document in form of a Bankers Cheque payable to the Kenya Urban Roads Authority. Bidders will be required to attach a copy of an official receipt to the bid document when submitting as proof of payment. For those who will download the document, they will be required to provide their details by registering at the Regional Procurement office -North Rift immediately after the site visit and before submitting the documents.

Qualification for Tendering (Mandatory)

The bidders are expected to include the following in their bids:-

(a) Certified Copy of Certificate of incorporation;

- (b) Certified Copy of VALID Registration Certificate with the National Construction Authority in the categories specified above and Valid Practicing License;
- (c) A copy of VALID Tax Compliance Certificate (Will be verified on the KRA TCC Checker);
- (d) Certified Copy of RECENT CR12 form generated through the system -(12 months before tender opening date) from Registrar of Companies; failure to which the bidder shall be disqualified;
- (e) Bidders shall sequentially serialize all pages for each tender document submitted; failure to which the bidder shall be disqualified;
- (f) Certified copy of a valid certificate of registration in a target group issued by the National Treasury or the respective County Treasury in the relevant category (Youth, Women & PWD).

Note:

- Certification of documents shall be original and executed by a Commissioner for Oaths.
- Submitted Documents by the Bidders shall be subjected to Due Diligence from the originating sources and shall be used for recommendation or disqualifications depending on the outcome;
- For those who will download the document, they will be required to provide their details by registering at the Supply Chain Management office of Respective Regions immediately after the site visit and before submitting the documents. Failure to which bidders shall be disqualified.
- No bidder shall be awarded more than one tender as advertised in this tender notice.


