A fully registered joint venture agreement executed according to the registration of documents acts must be submitted together with their tender, this requirement will form part of the tender;
- ❖ Preference and reservation for Citizen Contractors shall be implemented during evaluation as per the requirement of PPADA 2015 ACT and Regulation 2020 where the participation for the tender includes foreign contractors;
- ❖ Eligibility by means the tender is open to the Citizen, Local and Foreign Contractors.


The below clarification affects all tenders advertised on 9th February 2021 Funded by GOK and RMLF Budget.
