Bidders will be required to attach a copy of an official receipt to the bid document when submitting as proof of payment. For those who will download the document, they will be required to provide their details by registering at the Supply Chain Office immediately after the site visit/ pre-bid conference and before submitting the documents.

The bidders are expected to include the following in their bids:-

- ❖ Certified Copy of Certificate of incorporation;
- ❖ Certified Copy of VALID Registration Certificate with the National Construction Authority in the categories specified above and Valid Practicing License;
- ❖ A copy of VALID Tax Compliance Certificate (Will be verified on the KRA TCC Checker);
- ❖ Certified Copy of RECENT CR12 form generated through the system -(12 months before opening date) from Registrar of Companies; failure to which the bidder shall be disqualified;
- ❖ Bidders shall sequentially serialize all pages for each tender document submitted; failure to which the bidder shall be disqualified;
- ❖ Certified copy of a valid certificate of registration in a target group issued by the National Treasury or the respective County Treasury in the relevant category (Youth, Women & PLWD).

Note:

- ❖ Certification of documents shall be original and executed by a Commissioner for Oaths or issuing institution.
- ❖ Submitted Documents by the Bidders shall be subjected to Due Diligence from the originating sources and shall be used for recommendation or disqualifications depending on the outcome;
- ❖ All interested bidders are required to continually check the KURA website [www.kura.go.ke/tenders](http://www.kura.go.ke/tenders) for any tender addenda or clarification that may arise before the submission date.
