TENDER NOTICE

The Kenya Urban Roads Authority (KURA) is a State Corporation in the Ministry of Transport and Infrastructure (MOTI); established under Kenya Roads Act, 2007 with the core mandate of management, development, rehabilitation and maintenance of national urban road network. As a leading Government Agency with the above mandate, KURA wishes to invite bids from eligible construction companies for road works as described below to be funded through the Development Fund (GOK) and Fuel Levy Fund (RMLF).

Interested bidders **MUST** be registered with the National Construction Authority (NCA) road works categories as indicated below:-

Bidders may examine and obtain detailed tender documents during normal working hours, from the Supply Chain Management Department at Headquarters, situated along 4th Floor IKM Place 5th Ngong Avenue Opposite Bishops Gate upon payment of a non-refundable fee of **Kshs. 1,000** (Kenya Shillings One Thousand Only) for each document in form of a **Bankers Cheque** payable to the Kenya Urban Roads Authority. The same information may be accessed in our website at www.kura.go.ke/tenders. Bidders who will have purchased documents will be required to attach a copy of an official receipt as proof of payment. For those who will download the document, they will be required to provide their details by registering at the Supply Chain Management Department at Headquarters immediately after the site visit and before submitting the documents.

Qualification for Tendering (Mandatory)

The bidders are expected to include the following in their bids:-

1. **Certified** copy of Certificate of incorporation
2. **Certified** Copy of a valid Registration certificate with National Construction Authority (NCA) in the relevant category and Practicing Licenses from NCA.
3. Copy of Valid Tax Compliance Certificate (will be verified on the KRA TCC Checker)
4. **Certified** copy of CR 12 form (Recent within 12 months)
5. Bidders shall **serialize** all pages for each tender document submitted; failure to which the bidder shall be disqualified.

Note:

- Certification of documents shall be original and executed by a **Commissioner for Oaths**.
- Bidders who have been awarded tenders by KURA for the financial year 2017-2018 are ineligible to bid.
- For those who will download the document, they will be required to provide their details by registering at the Supply Chain Management Department at Headquarters immediately after the site visit and before submitting the documents. **Failure to which bidders shall be disqualified.**
- No bidder shall be awarded more than one contract

Other Requirements are as specified in the respective tender documents.

The Criteria of Evaluation of Bids

The criteria shall be as described in the Tender documents.

Description of Works

The description and scope of works is as described in the tender documents.

Completed tender documents enclosed in separate plain sealed envelopes and clearly marked with the Tender Number and Tender Name should be addressed and sent to the address below:

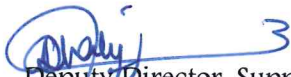
